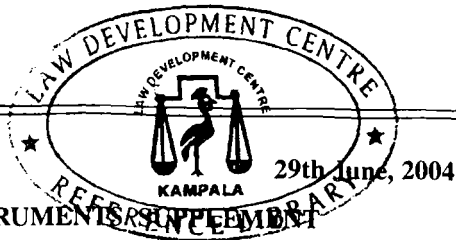

The External Trade (Prohibition of Importation of Certain Batteries) (Amendment) Order, 2004.

(Under section 8 of the External Trade Act, Cap 88)

IN EXERCISE of the powers conferred on the Minister by section 8 of the External Trade Act, this Order is made this 29th day of June, 2004. Cap. 88.

1. This Order may be cited as the External Trade (Prohibition of Importation of Certain Batteries) (Amendment) Order, 2004. Citation.

2. The External Trade (Prohibition of Importation of Certain Batteries) Order, 2004 is amended by inserting immediately after section 3, the following section— Insertion of section 4.

Order

4. (1) This Order does not apply to the following persons importing Tiger Head Primary Batteries in respect of the specified number of containers of batteries—

(a) M/S BALL PEN COMPANY LIMITED
